
विषय: सूचना का अधिकार अधिनियम, 2005 के अंतर्गत प्राप्त आवेदन ।

I, Dinesh kumar Teotia S/o Rajbir Singh, resident of H 1001, B tower, Classic Residency, Rajnagar Extension, Ghaziabad, mobile no: 9811274086, wish to seek information under the RTI Act, 2005 from Ministry of Mines, New Delhi. I, hereby declare that I am a citizen of India and information sought in this application will be used in the best of the public interest. I further assure you that, I shall not allow/cause to use/pass/share/display or circulate the information received in any case and under any circumstances, with any person or in any manner which would be detrimental to the Unity/Sovereignty or against the Interest of India.

The particular/details of information asked for is given below:

1. M/s Idha Enterprises Pvt Ltd located at 15, Pusa Road, New Delhi - 110005, had filed a Revision Application No: 12/(23)/2011-RC-II dated 29-04-2011 against the order bearing no F-2-72/2010/12 dated 29.01.2011, passed by the Under Secretary Department of Mineral Resources, **Government of Chhattisgarh**, whereby the Application for grant of PL no PL/09/2006 filed by us on 24-02-2006, area 2414 Hectare for Iron ore mineral, was rejected by the State Government. It has been more than two years now and no decision have been taken till date which has resulted in a loss of opportunity cost for our company.
2. The last hearing of our case was on 01.06.2012 and no further action has been taken by the Ministry of Mines since then.
3. Reference to letter No 01/(01)/2012-RC-II dated 02/05/2012 issued by the Revision Section, Ministry of Mines, Government of India whereby the Government of Chhattisgarh was requested to depute the concerned officer, duly authorized, to attend the hearing with relevant records on 01/06/2006 failing which the case will be decided ex-parte. However, no further proceedings have been done till now.
4. I would like to be informed of the next hearing date in our case and the reasons of the delay.

I have deposited the required RTI fee amount of Rs 10/- (Rupees Ten Only) towards application fee through cash (Receipt enclosed)/ Demand Draft/ Banker's Cheque/Indian Postal Order favoring

"PAO, Ministry of Mines". Further I also undertake to pay any additional fees/charges (if applicable) as prescribed under the RTI Act.
