M/s Idha Iron and Steel Ltd located at 15, Pusa Road, New Delhi - 110005, had filed a Revision Application dated 11-05-2007 against the order bearing no 686/F-149/DGM/RP/M/06 dated 01.03.2007, passed by the Under Secretary Department of Mineral Resources, **Government of Chhattisgarh**, whereby the Application for grant of RP no RP/M/06 filed by us on 25-01-2006, area 1033 sq.km for Gold, diamond and other base metals, was rejected by the State Government. It has been more than six years now and no decision have been taken till date which has resulted in a loss of opportunity cost for our company and also revenue loss for the government.


