

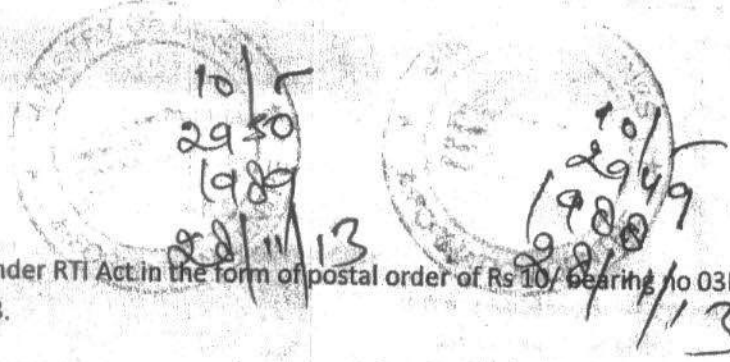

I would like to get information in the form of Certified copy of documents lying with your kind control.

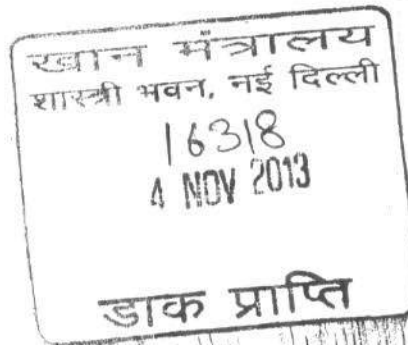


